What To Do When Setting Up A Program

- Provide full disclosure of dangers, and significant cultural and legal differences.
- Provide well-constructed and program-specific waivers and releases. Agreements should directly address issues related to legal jurisdiction.
- Make certain travel and hospitality arrangements provide detailed disclaimer language.
- For minors, get a parent or guardian to sign appropriate agreements and waivers.
- Have legal counsel review how federal requirements apply to international exchange programs.
- Verify students' health insurance to assure provision of coverage.
- Analyze institutional insurance to verify coverage in foreign jurisdictions. Policies to review include those governing general liability, property, automobile liability and wrongful acts.
- Consider buying kidnap-and-ransom insurance.
- Develop contingency plans. Know what to do in all of the events described in the section on Common Risks.
- Develop a good relationship with local consular representatives.

The Law

Three areas of law may affect the liability risks of institutional foreign travel and study abroad:

- Tort liability claims involving negligence, such as the failure to protect others from a reasonable risk of harm.
- Contract law documented relationships between participants and program, including any written agreements outlining responsibilities and rights of involved parties (i.e. program brochures, catalogs, posters, and letters).
- Federal regulations such as those governing discrimination, crime, disabilities and sexual harassment.

General Rules

Indemnification

Participant agrees to indemnify and release [] School District, its employees, elected or appointed officials against any loss or expense including attorney fees resulting from bodily injury, property damage, or personal injury arising out of any and all activities involved in the participant traveling outside of the United States. This hold harmless and indemnification does not apply to gross negligence on the part of [] School District, its officials, or employees.

Medical Insurance

Each participant will agree to purchase and/or maintain medical insurance covering accidental injury, dismemberment, and/or death. Insurance should be provided on a worldwide basis and confirmation of such insurance will accompany this form.

It is understood that [] School District is not responsible for lost or stolen personal property, airline delays, expenses, transfers, or hotel accommodations.

SAMPLE Foreign Travel Student Release and Waiver
