





OR-OSHA INSPECTION

If OR-OSHA showed up at your office to conduct a compliance inspection, would your staff know what to do? Who to call? Below you will find information to assist your district in developing a plan prior to a compliance visit.

When an OR-OSHA Compliance Officer shows up to your office:

- Verify by checking their credentials
- Contact your District Manager, Safety Officer, Risk Manager or designated person
- Have someone contact your insurance agent and/or the SDIS Risk Management Department if needed
- Determine what type of visit the compliance officer is there for
 - o Employee complaint
 - o Comprehensive inspection or partial inspection
 - o Safety inspection or health inspection
 - o Employee injury

Documents they may want to see include:

- OR-OSHA 300 Log
- Safety Committee training records
- Written safety programs
- Staff training records
- Safety Committee meeting minutes

Here are a few things to remember:

- They may interview employees
- · Hand them only documents requested
- · Fix any deficiencies right away if possible

Each district should be prepared at any time for an OR-OSHA visit. The inspector may want to see your paperwork and facilities. If you have the documents above, you are on your way to being prepared.
